Early Retiree HRA Plan Offering

Are you retiring soon? Do you want more choice when looking for the right health insurance coverage? The Early Retiree Health Reimbursement Arrangement (HRA) may be for you.

For benefit eligible employees under age 65, who are retiring soon, (i.e. July 1, 2018), you have the opportunity to voluntarily shop for health care coverage outside of the medical plans offered by the District. This program provides you the opportunity to comparison shop for more affordable health care coverage that fits your health care needs and your budget. If you find a more affordable health care plan that you would like to enroll in, you can use your negotiated District contribution to purchase that coverage through a Health Reimbursement Account (HRA). The HRA offers you several tax advantages and the opportunity to stretch your District paid benefits even farther. If you are satisfied with your District sponsored health plan, you do not need to do anything.

If you want an opportunity to see if more affordable health care coverage is available, you can meet with the District Benefits Office, or the Keenan representative at the District Open Enrollment meeting for more information.
